## **EVALUATION OF BIDS**

**N.B:** The evaluation of bid will be conducted in two stages. First stage it be the assessment of functionality as follows: company experience – 40 points, Bank rating – 10, plant and Equipment -30 point, Key personnel experience – 20 point; **only bidders that obtain 70 points will be evaluated further in terms of 90/10 Preference point scoring system, where 90 points will be allocated for price only and 10 points will be allocated based on the Broad Based Black Economic Empowerment (B-BBEE) status level of contributor. Contract period is 12 (twelve) months.**
