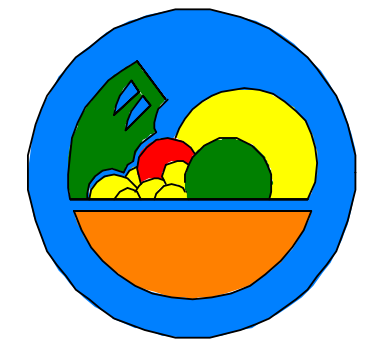

EVALUATION OF BIDS

Bids will be conducted in two stages: First stage will be the assessment of functionality only bidders that obtain 70 points will be evaluated in terms Preference point scoring system as stated above, where 90 or 80 points will be allocated for price only and 10 or 20 points will be allocated based on the Broad Based Black Economic Empowerment (B-BBEE) status level of contributor.

N.B: Bids which are late, incomplete, unsigned, faxed or emailed will not be accepted. Bid document will be available on 27 July 2016.
