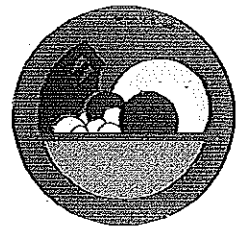

### EVALUATION OF BIDS

**Functionality criteria: company experience 40 points; Bank ranking 10 points; equipment & plant 30 points and key personnel/ site agent 20 points.** The evaluation of bid will be conducted in two stages. First stage it be the assessment of functionality, there after **only bidders that obtain 70 points will be evaluated in terms of 90/10** Preference point scoring system, where 90 points will be allocated for price only and 10 points will be allocated based on the Broad Based Black Economic Empowerment (B-BBEE) status level of contributor.
