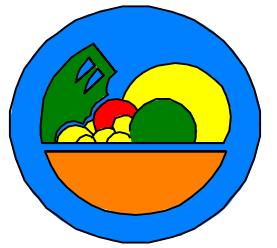

CSD report (Printed between the date of advert and closing date), Certified ID copies of all directors, Statement of municipal rates and taxes for both company and director(s) (not older than 3 months)/ letter from traditional authority not older than 3 months/ lease agreement, key personnel / Service team's experience (attach certified copies of qualifications and CV); CK/company registration; Valid tax Clearance and/ or Tax pin; certified or original Valid B_BBEE certificate or sworn affidavit, Proof of work experience (attach relevant Appointment letter).

N.B: The evaluation

SCMU 19/2018 & 20/2018 will be conducted in two stages. First stage will be the assessment of functionality as stated above, there after only bidders that obtain 70 points will be evaluated in terms of 80/20 preference point scoring system, where 80 points will be allocated for price only and 20 points will be allocated based on the Broad Based Black Economic Empowerment (B-BBEE) status level of contributor or sworn affidavit. Bids which are late, incomplete, unsigned, faxed or emailed will not be accepted.

SCMU 22/2018; 23/2018 & 24/2018 will be evaluated in terms of 80/20 preference point scoring system only; where 80 points will be allocated for price only and 20 points will be allocated based on the Broad

Based Black Economic Empowerment (B-BBEE) status level of contributor or sworn affidavit.
