Completed bid documents with attachments must be in a sealed envelope and deposited into the bid box of Greater Tzaneen Municipality, Civic Centre, Agatha Street, marked with the bid number(s) that the bidder is bidding for (as above in the table), as well as the bidder's postal address and contact details.

Evaluation of Bids

The evaluation of bids will be conducted in two stages. The first stage will be the assessment of functionality, thereafter only bidders that obtain 70 points will be evaluated in terms of the 90/10 or 80/20 preference point scoring system, where 90 or 80 points will be allocated for price only and 10 or 20 points will be allocated based on the Broad-based Black Economic Empowerment (B-BBEE) status level of contributor.

NB: Bids which are late, incomplete, unsigned, faxed or e-mailed will not be accepted.
