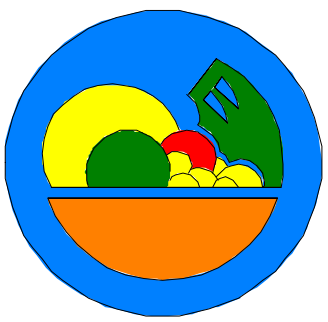

EVALUATION OF THE BID
