N.B: The evaluation of bids will be conducted in two stages. First stage will be the assessment of functionality as stated above, there after only bidders that obtain 70 points will be evaluated in terms of 80/20 preference point scoring system, where 80 points will be allocated for price only and 20 points will be allocated based on the Broad Based Black Economic Empowerment (B-BBEE) status level of contributor or sworn affidavit.
