Bid No: SCMU 09/2016 and SCMU 08/2016 will be evaluated in terms of preference point scoring system only and **SCMU 07/2016 & SCMU 10/2016** will be conducted in two stages: First stage will be the assessment of functionality, there after only bidders that obtain 70 points will be evaluated in terms of 90/10 Preference point scoring system, where 90 points will be allocated for price only and 10 points will be allocated based on the Broad Based Black Economic Empowerment (B-BBEE) status level of contributor. **Plant and equipment of the above bids should be owned and not leased. Services for all bids will be rendered as and when needed.**
