Evaluation of bids

Key personnel: 20 points, Plant & Equipment: 30 points. Second stage will be for bidders who obtain 70

points to be evaluated further based on point scoring of 80/20. Preference point scoring system will be

used where 80 points will be allocated for price and 20 points for Broad Based Black Economic Empowerment

(BBBEE) status level of contributor.
