Evaluation of Bids

Bid No: SCMU 31/2015 will be evaluated in terms of preference point scoring system as indicated above and SCMU 41/2015 & SCMU 42/2015 will be conducted in two stages: First stage will be the assessment of functionality, thereafter only bidders that obtain 70 points will be evaluated in terms of 90/10 or 80/20 preference point scoring system, where 90 or 80 points will be allocated for price only and 10 or 20 points will be allocated based on the Broad-based Black Economic Empowerment (B-BBEE) status level of contributor.

NB: Bids which are late, incomplete, unsigned, faxed or e-mailed will not be accepted.
