Bids are hereby invited from interested service providers with CIDB grading of 6CE or higher for Marumofase Pedestrian Bridge. Bid documents are obtainable at Finance Department – Supply Chain Management of Greater Tzaneen Municipality; Agatha Street, upon non-refundable fee of R250.00 per document payable at the Revenue Offices: Civic Centre, Agatha Street.

Interested service provider must give proof of the following documents to avoid disqualification:

- Key personnel experience (attach CV and Certified qualifications), certified ID copies, Company registration /CK form, Original TAX clearance certificate, relevant CIDB grading of 6CE or higher, proof of work experience (attach Appointment letters & completion certificates), Bank Rating (attach Bank letter with Bank rating) and Original or certified copy of B-BBEE Certificate.

Completed bid documents with attachments must be in a sealed envelope and deposited into the bid box of Greater Tzaneen Municipality, Civic Centre, Agatha Street, marked as Bid No: **SCMU 03/2016**; postal address & contact details of the bidder.

Bid document will be available on date of advert.

Compulsory briefing session and site inspection will be on the 13 May 2016 @ 10h00 at The Old Fire Department, Civic Centre, Agatha Street. Closing date: 20 May 2016 @ 12:00. Public bid opening will be held at the Council Chambers immediately after closing.

EVALUATION OF BIDS

N.B: The evaluation of bid will be conducted in two stages. First stage it be the assessment of functionality as follows: company experience – 40 points, Bank rating – 10, plant and Equipment – 20 point, Key personnel experience – 30 point; **only bidders that obtain 70 points will be evaluated further in terms of 90/10 Preference point scoring system, where 90 points will be allocated for price only and 10 points will be allocated based on the Broad Based Black Economic Empowerment (B-BBEE) status level of contributor.**

BIDDERS SHALL TAKE NOTE OF THE FOLLOWING BID CONDITIONS

- Greater Tzaneen Municipality Supply Chain Management Policy will apply;
- Broad Based Black Economic Empowerment (B-BBEE) Act will apply;
- Greater Tzaneen Municipality does not bind itself to accept the lowest or any bid and reserves the right to accept the whole or part of the bid;
- Council reserves the right to negotiate further conditions and requirements with the successful bidder;
- Council reserves the right not to appoint ;
