- 1. Connect 50mm² LV cable from Eskom 100kVA point of supply to the Circuit Breaker in the Distribution Box 1 to be located outside the hall
- 2. Connect a 25mm² LV cable from Distribution Box 1 outside to supply internal Distribution Box
- **3.** Connect a 35mm² bundle conductor from outside Distribution Board 1 to supply Distribution Board 2 on the stadium area.
- **4.** Install 5x 3 phase and 1 x 1 Phase air conditioning points in the hall
- 5. All materials, including circuit breakers and conductor to be supplied by the contactor
- **6.** Issue Certificate of Compliance (COC) for installation

The size of the hall is 1053m²

NB! The Electrical installation to the hall is done. The COC must confirm safety of installations in terms of SANS 10142-1. Code of Practice for the Wiring of Premises.
