EVALUATION OF BIDS

The evaluation of the bids will be conducted in two stages: First stage will be the assessment of functionality which is: Company similar work experience (Attach appointment letter/ completion certificate) - 25 Points, Bank Rating (Attach letter from bank) - 10 Points, Plant and Equipment (provide proof of ownership by the company, in case of JV proof by one company will be sufficient and tax invoices for plant which are not registerable at licensing) - 25 Points, Key personnel Experience (Attach CV and Certified Certificates of qualifications) - 40 Points. There after only bidders that obtain 70 points will be evaluated in terms of 90/10 Preference point scoring system, where 90 points will be allocated for price only and 10 points will be allocated based on the Broad Based Black Economic Empowerment (B-BBEE) status level of contributor.
