REPORT OF THE MUNICIPAL PUBLIC ACCOUNTS COMMITTEE CHAIRPERSON: COUNCILOR DG MKHABELA.

PURPOSE OF THE REPORT

The purpose of the report is to table before Council, the Municipal Public Accounts committee's oversight report on the 2020/2021 3rd quarter Service Delivery Budget Implementation Plan Report.

BACKGROUND

The 2020/2021 3rd quarter Service Delivery Budget Implementation Plan Report was tabled in Council during the meeting of the 26 July 2021 & 11th August 2021.

DISCUSSIONS

The Municipal Public Account Committee perused the 2020/2021 3rd quarter Service Delivery Budget Implementation Plan report during its committee meeting held on the 28 May 2021. Questions were drafted and sent to management to respond in writing on or before the 10th August 2021. The responses were given to the committee on the 16th August 2021, which has become a norm for management to disregard the time frames of the committee.

The committee made the following findings in the report:

- Payments arrangements have been made with Eskom to settle the utility bill, page 13 of 107.
- Page 14 of 107, indicates that the Annual Workplace Skills Plan was not implemented due to the service provider not being appointed.
- Mention was made of the traffic Cashier position which does not exist in the current Organisational Structure, page 15 of 107.

- Page 16 of 107 indicate that there are delays to commence with construction at CODESA, Pharare Cell C and Mandlakazi to Nwamitwa roads due to community interference.
- Page 39 of 107 indicate that street committees were supposed to be established per cluster.
- Target of traffic summons issued was not met due to the late arrival of the Sec 56 books, Page 15 of 107 Row D320.

CHALLENGES PER DEPARTMENT AS OUTLINED IN THE REPORT (1ST QUARTER SDBIP REPORT)

The challenges per department for the 2nd quarter SDBIP reporting are similar to the ones reported in the 1st quarter SDBIP 2020/2021, with a few new challenges under the 2nd quarter.
