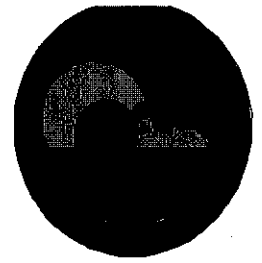

EXTENTION OF THE BID VALIDITY PERIOD

Bid Descriptions

1. SCMU 01 /2022: Electrification of 30 households at New Rita Village.
2. SCMU 02 /2022: Electrification of 75 households at New Phephene Village.
3. SCMU 03 /2022: Electrification of 35 households at Senakwe village.
4. SCMU 04 /2022: Supply and Delivery of Solid Waste Compactor Truck.
5. SCMU 05 /2022: Litter picking in Southern Waste Region (Nkowankowa) for GTM.
6. SCMU 06 /2022: Supply, Install, Commissioning of Traffic Lights Control Boxes, Training and Software.
7. SCMU 29 /2021: Panel of Suitable Service Providers for repairs and maintenance of Municipal Pumps and equipment's.

The National treasury has on 28 February 2022 issued a notice saying that all bids advertised on or after 16 February 2022 must be put on hold until further notice. However, the National Treasury has with effect from 06 May 2022 granted the Greater Tzaneen Municipality with an exemption from provisions of the PPPFA and regulations made thereunder.

Because of the above-mentioned reason, the Municipality will be commencing with the evaluation of the above-mentioned bids. The bids were advertised on the affected dates and closed on March 2022 and its validity period has been extended for a period of three months, until 30 September 2022.

REQUEST FOR EXEMPTION FROM PROVISIONS OF PREFERENTIAL PROCUREMENT POLICY FRAMEWORK ACT

1. I refer to your letter, received 25 April 2022, requesting an exemption from the application of the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000 - PPPFA) in order to continue with procurement processes so as to ensure that service delivery requirements are not negatively impacted and that your institution is able to fulfill its obligations in terms of its mandate.
2. Please be informed that the Minister has, in terms of section 3(c) of the PPPFA granted the request for an exemption from the provisions of the PPPFA and regulations made thereunder. The exemption is effective from **6 May 2022** until: -
 - (a) new Preferential Procurement Regulations take effect; or
 - (b) the Constitutional Court confirms the suspension of the order of invalidity of the Preferential Procurement Regulations, 2017, for a period of 12 months, whichever occurs first.
3. The exemption is limited to the specific categories of goods and services and values as stipulated in your application.
4. You are reminded that whilst the exemption is in effect, procurement must still comply with section 217 of the Constitution and other legislation applicable to your organ of state. You must ensure that the SCM system is not abused during the period of the exemption.
