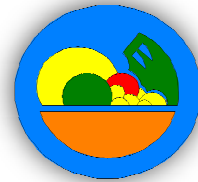

The job purpose of a Foreman Electrician is to maintain, promote and ensure electricity provision to the consumers. He/she will also be responsible for the safety of the personnel, contractors and consumers.

Key performance areas: The Foreman Electrician must ensure that the daily work is done to satisfaction and to achieve the objectives of Council. He/she will be responsible for:-
▲ Monitoring and supervising activities of staff to ensure that work is performed according to work plan, job-cards and ad-hoc instructions received from supervisor and reports on activities performed
▲ Monitoring and supervising utilization, application and maintenance of machinery, equipment, tools and material to ensure that they are fit for using by workers
▲ Performing administrative and human resources related activities in order to address staff problems to achieve synergy
▲ Maintaining and constructing electrical infrastructure as part of the Municipality's delivery programs
▲ Maintaining and performing operating activities of sub-stations, circuit breakers and transformers to ensure safety
▲ Performing driver activities using a vehicle to deliver tools to places of construction to ensure that work is completed according to plan
▲ Monitoring adherence to legal requirements in terms of electricity supply and issuing notices, when necessary.
