- No budget maintenance for infrastructure
- No allocation for the regional cemetery in Ward 10

Councillor C Bredenkamp indicated that DA rejected the final budget based on the increase of electricity tariffs, poor service delivery and insufficient funds on repairs and maintenance.

Comments by political parties

African Freedom Party - None.

African People Convention - None.

Freedom Front Plus - None.

Independent - Councillor E Ralepelle.

Councillor E Ralepelle raised a concern in terms of the budget in ward 34, where it was previously reported that a lower-level bridge is needed as it is a challenge in the community. He further indicated that the project was budgeted for the financial year 2024/2025 and is now moved to the 2026/2027 financial year. He further requested the Municipal Manager to assist on the matter. Councillor Ralepelle concluded by welcoming the 2024/25 Budget.

Democratic Alliance – Councillor C Bredenkamp.

Councillor C Bredenkamp indicated that the budget does not address the needs of the people in the ground, there is a lot of challenges in the townships and villages (rural areas) water, roads which needed to be addressed by this budget but not catered for. Councillor Bredenkamp concluded by indicating that the DA reject the budget for the 2024/2025 financial based on matters raised.

Economic Freedom Fighters – Councillor NR Lefuphana.

Councillor NR Lefuphana indicated that the EFF do not welcome the budget that is not considering priorities of the communities and based on the budget allocation to the unfinished Marirone project. He further raised concerns on the creation of speedhumps on the R36 road.

African National Congress – Councillor MG Malatji.

The Whip of Council, Councillor MG Malatji indicated that when the IDP/Budget process unfolds, some of the Council members choose not to attend or participate during the processes and at the later stage lament when the processes are finalised.

He further encouraged Councillors not to be choosy or selective when it comes to attending Council matters. The Whip of Council further indicated that the R36 is not a municipal road but SANRAL.

The Whip of Council indicated that he congratulated President Ramaphosa for signing the NHI as part of implementing the Freedom charter, which was a collective agreement in 1955 to allow the majority of South African people to be provided with better health care services. He further indicated that the signing of the Bill by the President on Wednesday, the 15th of May 2024 was a confirmation of the agreement.

The Whip of Council further indicated that the ANC as the ruling party in Council is trying to accommodate the communities and prioritize their needs with the limited budget. He further indicated that the ANC government will continue to listen to the people and implement the projects as per their needs.
