



CSD report (not older than 3 months), certified copies of ID's for all directors of the company, statement of municipal rates and taxes for both company and directors appearing in the CK (not older than 3 months)/ letter from traditional authority not older than 3 months for the company and the directors/ lease agreement (attach 3 months proof of payment for lease/statement from lessor not exceeding 3 months), valid Tax Clearance or Tax pin, certified or original B-BBEE certificate (combined BBBEE certificate if Joint Venture), signed joint venture agreements in case of a joint venture companies, initial every page of the bid document.

EVALUATION OF THE BID

N.B: 80/20 Preference point scoring system will apply, where **80** points will be allocated for price only and **20** points will be allocated based on the Broad Based Black Economic Empowerment (B-BBEE) status level of contributor. Point scoring system will not apply in **SCMU 02/2020**.
