

CSD report (not older than 3 months); Certified ID copies of all directors of the company, statement of municipal rates and taxes consigned jointly and directors appearing in the CK (not older than 3 months) / Copy of Lease Agreement with 3 Months proof of payment only (No statements) ; Certified copies of Permission to Occupy (PTO's) land for bidders residing in Tribal Authority's areas of jurisdiction / letter from traditional authority not older than 3 months for the company and the directors ; valid tax pin or tax clearance, signed joint Venture Agreement in case of a Joint Venture companies legally signed off by both parties and catalogue.
