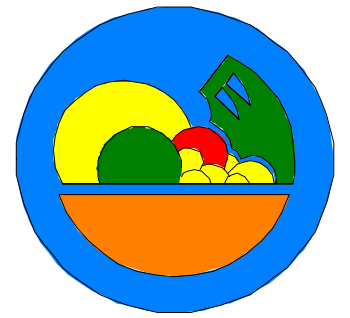

EVALUATION OF THE BID

N.B: The evaluation of bids will be conducted in two stages, first stage will be assessment on functionality (on bid no. SCMU 03,10/ 2020 and 21, 22 & 28/2021), second stage will be the Preference point scoring system where **80** points will be allocated for price only and **20** points will be allocated based on the Broad Based Black Economic Empowerment (B-BBEE) status level of contributor.
