## **EVALUATION OF BIDS**

**N.B:** The evaluation of the bid will be conducted in two stages. First stage will be the assessment on functionality: Key personnel experience (qualified Economist) – 30 Points, Proof of work experience in LED Strategy at local government (attach Appointment letters or order) - 40 Points, registration with any relevant body – 10 points, proposal – 20 Points, and only bidders that obtain 70 points in functionality will be evaluated in terms of 80/20 Preference point scoring system, where 80 points will be allocated for price only and 20 points will be allocated based on the Broad Based Black Economic Empowerment (B-BBEE) status level of contributor. Contract period: (6) six months.
