EVALUATION OF BIDS

N.B: The evaluation of bid will be conducted in two stages including a compulsory presentations of proposals. First stage it be the assessment of functionality: Bidder / Bidder Consortium Experience - 25 points; Professional Membership – 10 points; Proposal, Methodology and Approach - 40 points; Financial Capacity - 5 points; Skills and Resources - 10 points; Reporting - 10 points; thereafter only bidders who obtain a minimum of 75 points will be evaluated in terms of 80/20 Preference point scoring system, where 80 points will be allocated for price only and 20 points will be allocated based on the Broad Based Black Economic Empowerment (B-BBEE) status level of contributor. Shortlisted bidders may be called for presentation.
