TERMS OF REFERENCE FOR THE AUDITING OF THE TZANEEN LANDFILL SITE AND CALCULATION OF AVAILABLE AIR SPACE

1. INTRODUCTION

Greater Tzaneen Municipality operates a licensed landfill site. We are obliged to comply with the permit conditions and conduct an External Audit annually. Landfill sites must be managed and operated in a manner that protects the environment for the benefits of future and present generations. This is achieved through compliance to environmental legislative prescripts and other measures to prevent pollution and ecological degradation and promote conservation of natural resources.

2. PURPOSE

The aim is to appoint an experienced Environmental Consultant to conduct a landfill site audit and calculate the remaining air space for the permitted site.

3. SCOPE OF WORK

- i) To assess compliance of the Tzaneen landfill site with the relevant legislation and license conditions, focusing on operational practices, environmental monitoring, and engineering systems. This involves reviewing records, conducting site visits, and analyzing data to identify areas of non-compliance and recommend corrective actions. The audit should also evaluate the landfill's management practices against the "Minimum Requirements for Waste Disposal by Landfill" and other relevant legislation.
- ii) To calculate the remaining air space for the permitted site.
- iii) Present an Audit report and a landfill airspace report.
