



**SPECIFICATIONS FOR CCA TREATED GUM POLES FOR FENCING OF  
TAMBOTIE PARK NEXT TO R36**

Gum poles are needed to fence the side of Tambotie Park to prevent vehicles from driving through the park and onto the R36. Not only does this practice spoil the park but also create a danger on the R36 for passing vehicles.

***All the poles must be CCA treated (Chromated Copper Arsenate Treatment) to level H4 hazard class*** in accordance with SAWPA (South African Wood Preservers Association). In Chromated Copper Arsenate (CCA) treatment, copper is the primary fungicide, arsenic is a secondary fungicide, and an insecticide and chromium are a fixative, which also provides ultraviolet (UV) light resistance.

In accordance with SAWPA (South African Wood Preservers Association), H4 treated poles are suitable for ground contact and periodic wetting. These poles are ideal for agricultural posts, and landscaping. ***All poles must be issued with an anti-split plate (gang nail) at each end stating the SABS mark.***
