Purpose of the Report

To report back to Council on the 2015/16 mid- year report that was referred to the Municipal Public Accounts Committee by Council on February 2016.

Background

The Municipal Public Accounts Committee held a meeting on the 19th April 2016 to deal with the responses from Management, which was directed to them by the committee after it was referred to the committee by Council.
