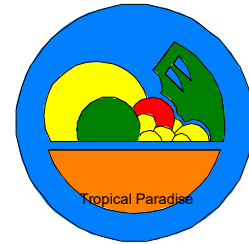

PUBLIC NOTICE

PUBLIC AWARENESS ON ILLEGAL OUTDOOR ADVERTISING WITHIN THE JURISDICTION OF GREATER TZANEEN MUNICIPALITY

Notice is hereby given in terms of Section 21 of the Local Government Municipal Systems Act, 2000 (Act 32 of 2000) to notify the public regarding illegal Outdoor Advertising procedures within the jurisdiction of Greater Tzaneen Municipality.

What is illegal Outdoor Advertising?

When a signboard is erected or displayed in an area or on a building or structure that is visible from any private land, street, road or painted on or attached to a boundary wall or fence, without first having obtained the written approval of the municipality.

In terms of the provisions of the Control of Outdoor Advertising and Signage By-Law of the Greater Tzaneen Municipality published in the Limpopo Provincial Gazette No. 3036 on the 27th of September 2019, "*No person shall display or erect any advertising sign or use any advertising sign or structure or device as an advertising sign without first having obtained the written approval of the municipality.*" The above provisions apply to both private and municipal owned land.

How to report an illegal Outdoor Advertising?

A complaint can be lodged in person, by calling, or sending an e-mail to the municipality, as directed below.

How to legalise Outdoor Advertising?

Outdoor Advertising applications should be submitted to Greater Tzaneen Municipality: Department of Planning and Economic Development (Tourism & Outdoor Advertising Office). The application form for Outdoor Advertising as well as the By-Law are available on the GTM website (www.greatertzaneen.gov.za) and in the Tourism & Outdoor Advertising office no. 1 & 12 situated at 15 Peace Street, Tzaneen.
