



2. PURPOSE OF THIS AGREEMENT
- 1.1 The Employer has entered into a contract of employment with the Employee in terms of section 57(1) (a) of the Local Government Municipal Systems Act, read with the Contract of Employment concluded between the parties to conclude an annual performance agreement referred to as "the Parties". The Greater Tzaneen Municipal Authority herein represented by Selemo Republic Monakedi in his capacity as Municipal Manager (hereinafter referred to as the Employer or Supervisor).
- 1.2 Section 57(1) (b) of the Systems Act, read with the Contract of Employment concluded between the parties, requires the parties to conclude an annual performance agreement.
- 1.3 The parties wish to ensure that they are clear about the goals to be achieved, and secure the commitment of the Employee to a set of outcomes and outputs that will secure local government policy goals.
- 1.4 The parties wish to ensure that there is compliance with Sections 57(4A), 57(4B) and 57(5) of the Systems Act.
- 2.1 Comply with the provisions of Section 57(1)(b), (4A), (4B) and (5) of the Act as well as the employment contract entered into between the parties.
- 2.2 Specify objectives and targets defined and agreed with the employee and to communicate to the employee's expectations of the employee's performance and accountabilities in alignment with the Integrated Development Plan, Service Delivery and Budget Implementation Plan (SDIP), the Departmental Business Plan and the Budget of the Municipality.
- 2.3 Specify accountabilities as set out in a performance plan, which forms an annexure to the performance agreement.
- 2.4 Monitor and measure performance against set targeted outputs.
- 2.5 Use the performance agreement as the basis for assessing whether the employee has met the performance expectations applicable to his job.
- 2.6 In the event of outstanding performance, to appropriately reward the employee.
- 2.7 Give effect to the employer's commitment to a performance-oriented relationship with its employee in attaining equitable and improved service delivery.

## PERFORMANCE AGREEMENT

3 COMMENCEMENT AND DURATION	
3.1	This Agreement will commence on the 1 July 2016 and will remain in force until 30 June 2017; thereafter a new Performance Agreement, Performance Plan and Personal Development Plan shall be concluded between the parties for the next financial year or any portion thereof.
3.2	The parties will review the provisions of this Agreement during June each year. The parties will conclude a new Performance Agreement on the first month of the successive financial year.
3.3	This Agreement will terminate on the termination of the Employee's contract of employment for any reason.
3.4	The content of this Agreement may be revised at any time during the above-mentioned period to determine the applicability of the matters agreed upon.
3.5	If at any time during the validity of this Agreement the work environment alters (whether as a result of government or Council decisions or otherwise) to the extent that the contents of this Agreement are no longer appropriate, the contents shall immediately be revised.
4 PERFORMANCE OBJECTIVES	
4.1	The Performance Plan (Annexure A) sets out-
4.1.1	the performance objectives and targets that must be met by the Employee, and
4.1.2	the time frames within which those performance objectives and targets must be met.
4.2	The performance objectives and targets reflected in Annexure A are set by the Employer in consultation with the Employee, and shall include key objectives, key performance indicators, targets that may include dates and based on the Integrated Development Plan, Service Delivery and Budget Implementation Plan (SDBIP) and the Budget of the Employer, and shall include key objectives, key performance indicators, targets that may include dates and
4.2.1	The key objectives describe the main tasks that need to be done.
4.2.2	The key performance indicators provide the details of the evidence that must be provided to show that a key objective has been achieved.
4.2.3	The target dates describe the timeframe in which the work must be achieved.
4.2.4	The weightings show the relative importance of the key performance areas, key objectives and key performance indicators to each other in terms of the position.
4.3	The Employee's performance will, in addition, be measured in terms of contributions to the strategic objectives and strategies set out in the Employer's Integrated Development Plan as developed per the Balanced Scorecard methodology.
5 PERFORMANCE MANAGEMENT SYSTEM	
5.1	The Employee agrees to participate in the performance management system that the Employer adopts or introduces for the Employer, management and multiprofessional staff of the Employer.

- The C.R.s will constitute the other 20% of the Employee's assessment score. C.R.s contained in the table below are all these competencies must be considered measurable and critical in assessing the performance of the Employee.
- 5.8 In accordance with Regulation 9 of the Local Government Regulation on appointment and conditions of employment of Senior Managers (Regulation no 21 of 2014). In accordance with this regulation all these competencies are essential and in the case of managers directly accountable to the Municipal Manager, key performance areas related to the function area of the relevant manager must be subject to negotiation between the Municipal Manager and the relevant manager.
- 5.7 In the case of managers directly accountable to the Municipal Manager, key performance areas related to the function area of the relevant manager must be subject to negotiation between the Municipal Manager and the relevant manager.

- 5.6 The Employee's assessment will be based on his performance in terms of the outputs / outcomes (performance indicators) identified as per attached Performance Plan (Annexure A), which are linked to the K.P.A.s, and will constitute 80% of the overall assessment result as per the weightings agreed to between the Employer and Employee.

- 5.5.3 K.P.A.s covering the main areas of work will account for 80% and C.R.s will account for 20% of the assessment.
- 5.5.2 Each area of assessment will be weighted and will contribute a specific part to the total score.
- 5.5.1 The Employee must be assessed against both components, with a weighting of 80:20 allocated to the Key Performance Areas (K.P.A.s) and the Core Competency Requirements (C.R.s) respectively.
- 5.5 The criteria upon which the performance of the Employee shall be assessed shall consist of two components, both of which shall be contained in the Performance Agreement.
- 5.4 The Employee undertakes to actively focus towards the promotion and implementation of the K.P.A.s (including special projects relevant to the employee's responsibilities) within the local government framework.
- 5.3 The Employer will consult the Employee about the specific performance standards that will be included in the performance management system as applicable to the Employee.

- 5.2 The Employee accepts that the purpose of the performance management system will be to provide a comprehensive system with specific performance standards to assist the Employer, management and municipal staff to perform to the required standards.

## EVALUATING PERFORMANCE

6.

- 6.1 The Performance Plan (Annexure A) to this Agreement sets out -
- 6.1.1 The standards and procedures for evaluating the Employee's performance; and
- 6.1.2 The intervals for the evaluation of the employee's performance
- 6.2 Despite the establishment of agreed intervals for evaluation, the Employer may in addition review the Employee's performance at any stage while the contract of employment remains in force.
- 6.3 Personal growth and development needs identified during any performance review discussion must be documented in a Personal Development Plan as well as the actions agreed to and implementation must take place within agreed time frames in the Personal Development.
- 6.4 The Employee's performance will be measured in terms of contributions to the strategic objectives and strategies set out in the Employer's IDP.
- 6.5 6.5.1 Assessment of the achievement of results as outlined in the performance plan:
- (a) Each KPA should be assessed according to the extent to which the specified standards or performance indicators have been met and with due regard to ad hoc tasks that had to be performed under the KPA.
- (b) An indicative rating on the five-point scale should be provided for each KPA.
- (c) This rating should be multiplied by the weighting given to each CCR during the contracting process, to provide a score.
- (d) The achievement levels for CCRs as provided for in Annexure A of Regulation 21 of 2014 and presented in Table 3 below, must be utilised
- 6.5.2 Assessment of the CCRs
- (a) Each CCR should be assessed according to the extent to which the specified standards have been met.
- (b) An indicative rating on the five-point scale should be provided for each CCR.
- (c) This rating should be multiplied by the weighting given to each CCR during the contracting process, to provide a score.
- (d) The achievement levels for CCRs as provided for in Annexure A of Regulation 21 of 2014 and presented in Table 3 below, must be utilised

## 6. Performance Assessment Process

The following steps will be followed to ensure a fully participative and compliant performance assessment process is adhered to.

1. Performance Assessment:
    - 1.1. Formal assessment between employee and employer will take place twice a year to measure the performance of the employee against the agreed KPI's and activities.
    - 1.2. Progress against the KPI's and Targets will be captured in preparation for the review.
    - 1.3. Scores of 1-5 will be calculated based upon the progress against targets.
    - 1.4. KPI's and activities are audited and copied to the Performance Plans before a assessment date.
    - 1.5. The employer must keep a record of the mid-year review and annual assessment meetings.
  2. The employee being assessed will compile a portfolio of evidence confirming the level of performance achieved for a given assessment period and made available to the Panel on request. One independent person may be assigned to act as an Observer.
  3. The process for determining Employee ratings are as follows:
    - 3.1. The employee to motivate for higher ratings where applicable.
    - 3.2. The panel to rate the achievement for the KPI's on a 5 point scale. Decimal places can be used.
    - 3.3. The panel to rate the employee's core competency requirements (CCR) on the 5 point scale. Decimal places can be used.
    - 3.4. The panel scores are averaged to derive at a total score per KPI / Activity /CCR. Overall scores are calculated by taking weightings into account where applicable.
  4. The final KPI's rating will account for 80% of the final assessment total. The CCR's are to account for 20% of the final assessment total.
  5. The five point rating scale referred to in regulation 805 correspond as follows:

  6. The assessment rating calculator is used to calculate the overall % score for performance.
  7. The half-year review rating can be used in combination with the Annual Performance Assessment to derive at a final Annual rating score.
  8. The performance bonus percentages described in the performance agreement will be calculated on a sliding scale of the all inclusive remuneration package as indicated in table below:


