The luminaire shall consist of Aluminium housing and high impact clear glass diffuser. A galvanized stirrup shall be supplied as standard for mounting the luminaire.

The luminaire shall operate LEDs of up to 500W and shall be adequate to replace traditional HID luminaires up of 1kW. The luminaire shall bear the SANS 475 performance mark and the SANS 60598-2-5

safety mark.

LED compartment and control gear compartment shall be IP 66 and be confirmed by necessary certification from recognized body
