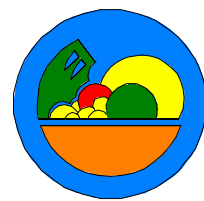

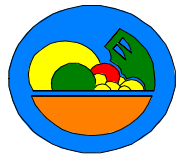

Risk Implications

Protection relays require a reliable DC power source to detect within the power system. Without DC power, these relays are inoperable.

High-voltage circuit breakers use DC power for both tripping and closing coils. If the DC supply fails, the breakers cannot operate to isolate faulty sections of the grid, potentially leading to cascading failures, and severe damage to expensive equipment like power transformers.

Legal Implications

In terms of NERSA Distribution Operating Code (version 6.1 Section 3[1]): The *Distributor (Greater Tzaneen Municipality)* shall operate the *Distribution System* to achieve the highest degree of reliability and shall promptly take appropriate remedial action to relieve any condition that may jeopardize reliability.
