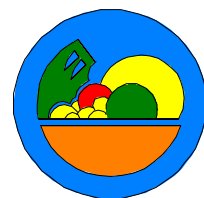

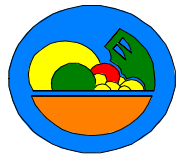

### **1. Introduction**

Greater Tzaneen Municipality invites qualified suppliers to submit quotations for the supply, delivery of Road Signs for the Traffic Department. This RFQ outlines the technical specifications, terms, and conditions for the procurement process.

### **2. Scope of Work**

The scope includes:

- Supply, delivery, of all listed items.
- Compliance with specifications, quality standards, and timelines.
- The supply and delivery of Road Signs to Traffic Department (exact address to be provided post-award).

### **3. Detailed Specifications**

#### **3.1 New traffic signs**

Specifications

- 1.4mm thick chromadek steel for all permanent signs
- Reflector material must be class 1 Engineering grade prismatic sheeting
- Vinyl for Road signs must be cast vinyl with a 10-year warranty and SABS
- All signs reinforcement Unistrut's, steel T- piece at bottom and SABS approved galvanized clamps included.

Poles 2 mm Galvanised D poles with a length of 2.4 meters all painted in enamel SABS Grey paint

Road Cones Soft

- Orange Traffic safety cone 450mm with orange base.
- Traffic cones made of Premium grade PVC construction assures flexible high visibility dayglo plastic material with the colour moulded into the cone and a heavy base to keep traffic cone upright and on the road.
