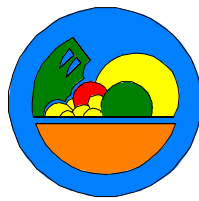

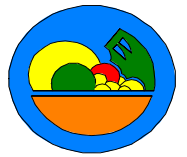

SPECIFICATION FOR THE SUPPLY AND DELIVERY OF SOIL COMPACTION METER

1. Description

The soil compaction meter should be a portable, handheld device used to measure the compaction of soil, providing accurate and reliable readings for construction, agriculture, and environmental applications.

2. Minimum Requirements

- Measurement Range: 0-1000 kPa (or equivalent units, e.g., pounds per square inch (psi))
- Accuracy: $\pm 2\%$ of full scale
- Resolution: 1 kPa (or 0.1 psi)
- Probe Type: Penetrometer or equivalent, with a conical or cylindrical tip
- Display: Digital, with clear and readable output (e.g., LCD)
- Power Source: Battery-powered (e.g., AA or rechargeable)
- Operating Conditions: Temperature range: 0°C to 50°C, humidity: 0-90% RH
- Dimensions: Compact and lightweight, with a carrying case or handle
- Units: Metric (kPa) and/or Imperial (psi)

- Data logging and storage capability
- Bluetooth or USB connectivity for data transfer
- Waterproof or water-resistant design
- Adjustable measurement units
- Calibration certificate or documentation
