TERMS OF REFERENCE FOR THE REPAIR AND CALIBRATION OF THE WEIGHBRIDGE AT THE TZANEEN LANDFILL SITE.

1. INTRODUCTION

Greater Tzaneen Municipality operates a licensed landfill site.

We are obliged to comply with the permit conditions and calibrate the weighbridge on a yearly basis.

2. PURPOSE

The aim is to appoint a registered and experienced Weighbridge Consultant to repair the weighbridge, upgrade the hard and software, train landfill employees, and issue a calibration certificate for the weighbridge.

3. SCOPE OF WORK

To assess the status of the Weighbridge at the Tzaneen landfill site with specific focus on the weighing pressure cells, hard and software components to comply with relevant legislation.

- i) Present a Calibration certificate.

4. REQUIREMENTS

Mandatory submission of documents

1. To calibrate and verify weighbridges, a company must hold formal **SANAS accreditation** (ISO/IEC 17025)
2. Must be registered as a Verification Body with the **NRCS (National Regulator for Compulsory Specifications)**.
3. Technicians must have **Legal Metrology certification**, and the company must possess **traceable certified test weights** and heavy lifting equipment.
4. **Certified Test Weights:** The company must utilize specialized mass test weights that are traceable to national/international measurement standards. These weights are often stacked up to the maximum capacity of the weighbridge.
5. **Heavy Haulage Plant:** Calibrating a heavy-capacity scale requires logistical capabilities. The company must have specialized equipment to transport these masses, such as crane trucks or forklifts

5. PRICING INSTRUCTIONS

The pricing should cover the following aspects for the Repair of the weighbridge:

- Project inception
- Review of documents
- Repair of weighbridge
- Provision of Soft and Hardware
- Development of a Weighbridge report
- Training of weighbridge personnel.
