Calling For Inspection Of Second Supplementary Valuation Roll 2025–2026 And Lodging Of Objections



Greater Tzaneen Local Municipality hereby gives notice in terms of Section 49 (1)(a)(i) read together with section 78 (2) of the Local Government Municipal Property Rates Act 6 of 2004 that the Second Supplementary valuation roll for financial year 2025/2026 is open for inspection, comments and /or objections. The supplementary valuation roll documents will lie for public inspection in the Municipal offices, No. 1 Agatha Street, Civic Centre, Tzaneen, Lenyenye satellite office, Nkowankowa satellite office, Letsitele library, Haenertsburg library, as well as municipal website for 30 working days from 14th August 2026 to 22nd September 2026 being the date of publication of the notice during normal office hours (Monday to Friday, 8h00–16h30) at the following places–:

Invitation is hereby made that any owner of the property or other interested and affected person to lodge an Objections against the Supplementary valuation roll with the Municipal Manager within the period mentioned above by completing a prescribed form obtainable from the below mentioned offices or through a municipal website at: www.greatertzaneen.gov.za. Letsitele Library, Nokwankowa Satellite office, Lenyenye Satellite office, Haenertsburg Library and Tzaneen Civic Centre.

An invitation is hereby made in terms of Section 49(1)(ii) of the Act that any owner of the property(ies) or other person who so desires should lodge an objection(s) with the municipal Manager in the prescribed manner in respect of any other matter reflected in or omitted from the valuation roll within the above-mentioned period.

In terms of Section 50(2) of the Act, objection(s) must be in relation to specific individual property and not against the valuation roll as such. Prescribed forms for the lodging of objections are obtainable from the above-mentioned municipal offices and municipal website provided above. The completed prescribed objection(s) form(s) must be returned by hand to any of the above-mentioned municipal offices during normal office hours as indicated above or can be posted to:
